General Instructions:	<p>Paint application: Mix 50 g of product with 200 mL of lukewarm water and 200 g of sugar, mix well until it forms a paste sufficiently liquid that it can be applied with a paint brush. This amount should be used for paint stripes covering approximately 10 – 12 square meters in total area.</p> <p>If insufficient surface area is available or where some light discolouration would be unacceptable, paint the solutions onto pieces of cardboard or with wood and hang from the ceiling.</p> <p>Mixing Add the required quantity of BELACRON 500 WP Insecticide to water in the spraying equipment used and stir well. If the mixture is allowed to stand, stir well before using.</p> <p>Spray Application Use the higher rate on porous surfaces, such as concrete, OR for longer control. Apply spray mixture to just below the point of run-off. NOTE: Once dry, the spray mixture may leave a visible deposit on dark or shiny surfaces. Test prior to treatment.</p> <p>Fly Bait treatment: Use in dry conditions may require a light application of water to keep the applied surface moist and attractive to flies. 	<p>Flies - Bait treatment</p>	<p>Paint: Mix 50 g of product + 200 g sugar with up to 200 mL of lukewarm water to make a brushable paint.</p>	<p>Paint strips of 5 cm x 30 cm where flies congregate, e.g. warm wall areas, partitions, posts, milk pipes, etc. Where insufficient space is available for painting or where slight discolouration would be unacceptable, paint strips of cardboard, polyethylene or light boards and hang them from the ceiling.</p>
