	24.7 SMARTRACE ADULT SHEEP ORAL BOLUSES are for the oral administration of iodine, cobalt and selenium to sheep over 40 kg liveweight.
	24.7 SMARTRACE ADULT SHEEP ORAL BOLUSES lie in the ruminoreticulum, the wrapper or the bolus dissolves and the bolus splits into two parts. These erode and dissolve, thus providing a supply of trace elements to the animal for at least 4 months following administration.

Contraindications:	This product is contraindicated for use unless cobalt deficiency is confirmed. This product is contraindicated for use in sheep that are dehydrated or unwell. This product is contraindicated for use when selenium intake from pasture is high or selenium is provided by other means (such as top dressing, vaccine, pellets or selenium drenches) if blood selenium levels at treatment are high. Users can determine selenium status by consulting their veterinarian. DO NOT administer additional iodine, cobalt or selenium for at least 6 months following treatment, unless under veterinary advice.

Dosage and Administration:	Administer orally using only an approved Agrimin bolus applicator.
	Dosage:
	One (1) bolus should be administered per animal weighing over 40 kg.
	Administration:
	Bolus administration requires care and attention with sheep. NEVER use force or push the applicator too far down the animal's throat.
	1. Load the applicator.
	 ✓ Insert one (1) bolus into the head of the applicator. ✗ DO NOT remove the paper wrapper.

	2. Position the applicator.
	 ✓ Gently insert the applicator into the mouth and guide over the back of the tongue. ✓ Keep the applicator straight with the handle in front of the nose.
	✓ Keep the head up and neck straight.
	✗ DO NOT use severe restraint such as gripping the tongue or holding the head too high. [Image 2]
	3. Release the bolus.
	✓ As the animal begins to swallow, gently eject the bolus. Apply pressure to depress the plunger
	X DO NOT push the bolus applicator too far into the throat.
	 X DO NOT use force as you may damage the sheep's throat. X The bolus cannot be swallowed if the head is pointing down.
